

Asbestos Disease Compensation

If you have been diagnosed with an asbestos disease, it is highly likely that you will be entitled to substantial compensation. Our team at vbr Lawyers are experts in conducting asbestos disease and other dust disease compensation claims.

We claim compensation for all asbestos related diseases including:

- MALIGNANT MESOTHELIOMA a cancer of the pleura (the lining surrounds the body's internal organs) usually in the chest/upper back but occasionally in the abdominal region. Can be caused by very light asbestos exposures.
- LUNG CANCER Cancer of the lung tissue usually caused by heavy and prolonged asbestos exposure. An entitlement to compensation can be established even where there is a history of smoking.
- OTHER CANCERS we have successfully claimed compensation for other cancers, including cancers of the kidney and oesophagus, where a significant history of asbestos exposure is present.
- ASBESTOSIS scarring of the lung tissue caused by heavy asbestos exposure resulting in breathing restriction. Not a cancer but symptoms can worsen with time.
- ASBESTOS RELATED PLEURAL DISEASE –
 non-cancerous but often symptomatic changes to
 the lining of the lung including plaque formation
 and thickening that can cause shortness of breath
 and chest pain.

Compensation may also be available for other types of industrial disease including:

- SILICOSIS Scarring of the lung tissue caused by the inhalation of silica, commonly encountered in mining and foundry work, quarrying of sandstone.
- CANCER Cancers of the lung and other tissues are associated with exposures other than asbestos, including nickel processing and general fumes and smoke.
- OCCUPATIONAL ASTHMA We have handled numerous claims involving occupational asthma including asthma caused by exposure to welding fumes, to plastic fumes, pharmaceuticals, and wood dust.
- COPD/EMPHYSEMA Often associated with smoking, these conditions are also known to be caused by occupational exposures - most commonly in coal mining but also from other exposures such as to welding fumes.


